15. To review the Reserves

The Clerk reminded members the Council had a reserve fund for the renewal of the remaining play equipment in Ferryfield, referred to as Phase 2 of the project. These funds were not needed as the Council was successful in obtaining a grant from the FCC Communities Foundation of £58,974.74.

The Clerk requested the Council's authorisation to transfer £4,179.62 from this reserve into the Cemetery budget to meet the shortfall of the cost to replace the Cemetery fencing. **Agreed**

The Clerk also requested the Council's authorisation to transfer £3,017.50 from this reserve into a suitable budget code to fund the cost of the replacement streetlight in Old Bridge Gardens. **Agreed**

The Clerk asked the Council to consider reallocating the remaining funds from the Ferryfield Phase 2 Project to a new budget code "General Parish Improvements" and this could help fund several improvements around the Parish, such as those that were identified or suggested during the recent organised mini-bus trip around the Parish that some members went on. It could also assist with general tidying up within the Parish. The amount to be reallocated is £50,699.23. **Agreed**

A Councillor requested that two new Christmas Light motifs be considered for Eccles using these unallocated funds. After discussion it was **Agreed** this item will be added to a future agenda of the Environmental Services Committee.

GENERAL ELECTION

AYLESFORD NORTH & NORTH DOWNS ISSUES

ENFORCEMENT ACTIONS IN PROGRESS

General

6. There has been little change in the ongoing enforcement actions in the ward since your last meeting.

Nursery Rochester Road Aylesford

7. No change on this report since last month. This application has been appealed and is now with the Planning Inspectorate. All other enforcement action must wait for the outcome of that appeal.

Land Rear of Mackenders Lane Eccles Aylesford Kent

- 8. Little change since the last report as the owner failed to attend the visit on the 10th June and another meeting with him is being set up.
- 9. There is a farm building that has been built in the last few months but that now is understood to be complete. It is a building for farm use such as storing farm machinery in. This building is permitted development.
- 10. There is also a caravan on site that is been occupied during the period of construction of the permanent building above. This is the subject of the enforcement action.

Land On Former Scout Camp Warren Road

11. This is with the legal team. Another prosecution is now pending and hopefully this will happen before the end of the year.

Land North of Lower Warren Road and East of Warren Road

- 12. Little change from the last report as we are now waiting for the 22 July enforcement deadline and any resultant follow up action.
- 13. As you know there have been 3 applications for the land:
 - a. 20/01125/FL Extension to existing stables Approved
 - b. 20/01845/RD Drainage conditions for above - Approved
 - c. 22/00417/NMA Addition of windows change of openings Refused 25 Mar 22.
- 14. The last application resulted in two Enforcement Notices being served on 14th April 22 to two different people for the same reasons. This in turn led to two appeals to the Planning Inspectorate.
- 15. The appeal decision has come in with the Enforcement Notices upheld with a slight variation. This means their appeal has been dismissed and they must still carry out all necessary internal and external works so that the stable building is in accordance with the terms and conditions of approved planning permission TM/20/01125/FL. The 2-month compliance period, which will have been held in abeyance until the date of the appeal decision, means the new deadline is now 22 July. A compliance check will be arranged once this deadline has elapsed and before the case is closed.
- 16. Technically that does not mean that he can't live on the site but all the work to make it habitable must stop and be rectified.

AYLESFORD SOUTH AND DITTON

17. There are no specific Aylesford South ward items to report this time.

WALDERSLADE WARD
